Sir,

I, PSI Chiranjit Saha of Bhaktinagar P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against namely; (1) Manoj Lama, S/O- Gopi Lama(M/37 years), Gitalpara,behind Ganesh Bhaban,Iskcon Mandir Road, W/no-40 PS- Bhaktinagar Dist-Jalpaiguri (2) Sunny Singh, (M/37 years), S/O-Lt.Jaswinder Singh, of Durgahagar near Kali Mandir, W/no-40 PS- Bhaktinagar Dist-Jalpaiguri, under arrest along allowing with following articles; (i) One (01) Iron Rod measuring approx. 48" (seemed to be implement of house breaking) recovered from the possession of Manoj Lama which was kept on his right hand (ii) One (01) knife fitted with plastic butt measuring approx. 09" recovered from the possession of Sunny Singh which was kept in his waist.

In this regard, I beg to report that on 08.09.2022 at 01.15 hrs received secret reliable source information that about 10/12 anti socials armed with deadly weapons assembled at Fauji Math near Payara Singh Dhaba under Bhaktinagar PS making preparation to commit dacoity at Bhaktinagar PS area . I informed the source information to IC Bhaktinagar PS and noted the information vide Bhaktinagar PS GDE No. 374 Dated 08/09/2022 As per the direction of IC Bhaktinagar PS, at 01.25 hrs, I along with ASI Dipak Karmakar, C/1431 Dilip Barman CVF/619 Dharmendra Roy, CVF-935 Biplab Roy, CVF/614 Sumit Barman left for working out the information vide Bhaktinagar PS GDE No. 375 Dt. 08.09.2022 after briefing officer and force properly and also along with required papers / articles. At around 02.05 hrs we reached near Fauji Math near Payara Singh Dhaba side and kept our vehicle at considerable distance. Then, I along with Officers and force headed towards Fauji Math near Payara Singh Dhaba looking for witnesses, if any on the way and found witnesses namely; (1) Prabhat Prasad, S/O- Ram Prasad of Vivekananda Nagar, W/N-42,PS- Bhaktinagar, Dist- Jalpaiguri (2) Rajib Roy S/O-Bablu Roy of Bhupendra Nagar, W/N-42,PS- Bhaktinagar, Dist- Jalpaiguri and requested them to be present during search and seizure if any. By the time we reached Fauji Math near Payara Singh Dhaba , as informed by secret source, in faint light of street lights on the west side corner, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted two persons had been apprehended and detained. Then, after disclosing our identity, I asked them their motive to assemble at such a

place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with 8/9 others assembled at the spot making preparation to commit dacoity tonight at Bhaktinagar PS area. I accordingly searched them in presence of witnesses and found (i) One (01) Iron Rod measuring approx. 48" (seemed to be implement of house breaking) recovered from the possession of Manoj Lama which was kept on his right hand (ii) One (01) knife fitted with plastic butt measuring approx. 09" recovered from the possession of Sunny Singh which was kept in his waist. On interrogation, they admitted that they all assembled there at the behest of Sunny Singh were making preparation for committing Dacoity tonight in Bhaktinagar PS area but 8/9 others managed to escape. Accordingly, I seized above noted weapons in presence of above mentioned witness under proper seizure list duly signed by them and arrested them informing them their ground of arrest preparing memo of arrest. The seizure was made in between 03.25 Hrs to 03.45 Hrs on 08/09/2022.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity at nearby Bhaktinagar PS area.

Further, it is to mention here that the arrested accused persons are well known anti socials and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against them and 8/9 others who fled away under proper section of law and to cause its investigation.
