In producing herewith five (09) arrested accused persons namely (1) Baiju Sahani(21) S/O- Late Chanda Sahani of Ratanlal Busty , P.S- Pradhannagar Dist- Darjeeling ,(2) MD. Mustafa(26) S/O- MD. Mokim of Ratanlal Busty , P.S- Pradhannagar Dist- Darjeeling, (3) MD. Sagar(26) S/O- Late MD..Mobarak of Biswas Colony near Railgate P.S- Matigara, Dist Darjeeling , (4) MD. Majamil (24) S/O- Late MD. Atabul of New Pokaijote , P.S- Pradhannagar ,Dist- Darjeeling , (5) Shiba Chettri(22) S/O- Late Suresh Chettri Sourini Bazar, P.S- Mirik ,Dist- Darjeeling , (6) MD. - (6) one Iron made Katari measuring 22 inches from the possession of MD. Safiqul which was kept on his right hand,
- (7) One Chesel measuring 1 ft approx from the possession of Chan Sharma.
- (8) One Iron rode measuring 3 ft approx from the possession of Pala Khan which was kept on his right hand,
- (9) One Torch light from the possession of Tashi Rai.

I, SI Sibdhan Karmakar S/O- Birendra Nath Karmakar of Pradhannagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (1) Baiju Sahani(21) (2) MD. Mustafa(26) (3) MD. Sagar(26) (4) MD. Majamil (24) (5) Shiba Chettri(22) (6) MD. Safiqul @ Takla(23) (7) Chan Sharma (20) (8) Pala Khan(20) (9) Tashi Rai (22) Sikkim (not verified) to the effect that today on 26.09.2022 at 01.15 hrs .While myself along with ASI-Manoj Kumar Roy ,C/992 Majibur Rahaman , CV-128 Ajoy Kumar Sahani ,CV-646 Baban Das , Cv-992 Jagadish Biswas and CV-645 Pankaj Gupta all of Pradhannagar P.S. were performing night patrolling duty vide Pradhannagar P.S. G.D. E. No- 1586 at that time received a sources information that 10/12 youths have assembled near Dagapur Tea Garden with a view to commit dacoity at Panchanai area under Pradhannagar P.S . Subsequently, after sharing the information with my superiors and as per their direction, I along with force left for the place to work out the information. At about 01.35 hrs after reaching Dagapur Tea Garden under PS-

Pradhannagar . I met my source and being pointed by my reliable source approached towards 10/12 persons standing there and whispering each others . At that time seeing the Police party approaching towards them they started flee away from the spot in multi direction ,however we managed to apprehend the above noted 09 persons and two and three others able to flee away from the spot by taking the advantage of darkness.. On interrogation the accused persons admitted that they had assembled there to commit dacoity at Panchanai area .

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 02.05 hrs to 02.55 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons.

I accordingly brought the arrested accused persons along with seized articles at Pradhannagar Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity at Panchanai area under Pradhannagar P.S area. It is also revealed from them that three others namely Gopal Karmakar , Suraj Chettri and Shiba Barman have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Baiju Sahani(21) S/O- Late Chanda Sahani of Ratanlal Busty , P.S- Pradhannagar Dist- Darjeeling ,(2) MD. Mustafa(26) S/O- MD. Mokim of Ratanlal Busty , P.S- Pradhannagar Dist- Darjeeling, (3) MD. Sagar(26) S/O- Late Mobarak of Biswas Colony near Railgate P.S- Matigara, Dist Darjeeling , (4) MD. Majamil (24) S/O- Late MD. Atabul of New Pokaijote , P.S- Pradhannagar ,Dist- Darjeeling , (5) Shiba Chettri(22) S/O- Late Suresh Chettri Sourini Bazar, P.S- Mirik ,Dist- Darjeeling , (6) MD.
