**Sub: Complaint against Ganesh Roy Son of Nagen Barman  
for abducting my wife Smt. Janabala Barman.**

Dear Sir,

I, Gopal Barman, Son of Late Nandeshwar Barman, resident of Vivekananda Nagar, SMC Ward No. 42 P.O. Salugara, P.S. Bhaktinagar, District- Jalpaiguri, would like bring to your knowledge that my wife Smt. Janabala Barman use to work as labour under Ganesh Roy, son of Nagen Barman presently resident at Vivekananda Nagar, SMC Ward No.42 P.O. Salugara, P.S. Bhaktinagar, District Jalpaiguri and permanent resident of Majibari, Mondal Ghat, Bamandanga, Mathabhanga. District Coochbehar and on 25-11-2021 she went to work under the said Ganesh Roy but she did not return to home at her scheduled time. I tried to search her with the local people but without any result. I also searched for her at my in laws place at Majibari Checkpost, Chenakata, Mathabhanga, District Coochbehar and at the above permanent residence of Ganesh Roy, on the instance of local people there he agreed to produce my wife, but he fled from there and is not traceable since then. On being unable to trace whereabouts of my wife I lodged a complaint with the Bhaktinagar Police station on 01-02-2022 vide BKN P.S. GDE No.58. On further search it came to my knowledge that the above-named Ganesh Roy had enticed my wife and taken her knowing well that she is my wife and have three children from me with intent better known to him.

Sir, even after my full efforts to search her I am unable to find her but her mobile no 7001159099 was switch off since then but I received a call from mobile no 9679843341 Four months ago and my wife talked over the call which I again informed the concerned Police station to which they stated

that the mobile number belongs to Chalsa, Alipurduar District and they shall take appropriate actions. The above-named Ganesh Roy also had mobile no 9382009784.

Sir, I have three children to look after and I suspect that above named Ganesh Roy have immorally and illegally trafficked my wife thus I request you to kindly look into the matter and track and find the whereabouts of my wife to save her life and take appropriate legal actions against the above-named Ganesh Roy.
