Jalpaiguri, W.B., beg to report you that my minor younger sister Miss. Sneha Rajawat, aged about 15 years (Date of Birth - 17.07.2007), has been missing since 15.11.2022. That she was in the house till 5.30 p.m. and thereafter she has been missing and could not be found inspite of search in all the possible areas. I have searched for her in her friend's house, house of our relatives, her school etc but she could not be found till date.

That she is around 5 feet in height and has wheatish complexion and was last seen in black hoodie top and green lower with pink slipper. That she is also wearing one gold chain and one golden finger ring. That her photograph is being enclosed with this missing diary.

That her identification marks are:

- (a) She has a bent spinal cord and she cannot walk straightly and limps;
- (b) Her right shoulder is always elevated then her left shoulder;
- (c) A cut mark above right eyebrow.
