SUBJECT : COMPLAINT AGAINST BISWAJIT MISHRA & HIS WIFE

Sir.

With due regard and humble submission I Smt. Usha Mishra wife of late Narayan Mishra, resident of Maharaj Colony, Ward No-V(SMC), P.O & P.S- Siliguri, Dist- Darjeeling do hereby submit the following facts for your kind perusal and necessary legal action :-

1. That my husband Narayan Mishra died on 9<sup>th</sup> April 2021, leaving behind him myself and one Married daughter and Married Son namely Biswajit Mishra as the only legal heirs.
2. That after few day of the death of my husband my son namely Biswajit Mishra and his wife started to torture me mentally and physically and I use to tolerate with a hop that they would change their attitude but all in vain.
3. That my said son took my shop for his business purpose and I had paid him money to start his business properly and he promised me that he would maintain me and look after me properly.
4. That my said Son do not allow my daughter namely Jyoti Mishra to meet me at my residence and when she come to meet me then he and his wife namely Roshani Mishra abuse me and daughter and threaten that if she will come then he would kill me and my said daughter with the help of some antisocial elements and they also do not allow any relative to meet me.
5. That my said son do not allow my grand children to meet me and if I meet them then he beat them and abuse me in filthy language and also beat me .
6. That on several times my said Son have taken huge amount of money from me for his business purpose and if I refuse then he beat and threaten me that he would kill me and due to fear I have to pay money for his business purpose in order to save my life.
7. That few days back my said son forcefully took Rs. 50,000/- from me in a illegal manner.
8. That my said son and daughter in law never provided me food to eat and I have to cook myself and they only demand money from me in a illegal manner and I have become old and my health do not permit to do all house hold activities .
9. That each and every day my said son and his wife is torturing me frequently and demanding more money from me and if do not pay them then they beat me and threaten to kill me and my daughter or involve in a fake case and put behind the Iron bars and due to fear I have taken shelter in the house of my known person to save my life..
10. That my said son and his wife have ruined my life and during my old age I am being tortured by them continuously in a illegal manner for money.
11. That on several times I have provided them huge amount of money with a hope that they would provide me food and let me live peacefully in my old days but all in vain and they start their illegal act and activities and have made my life horrible .
12. That my said son and daughter in law always behave rudely with me and my daughter and always threaten that if I complain to any person or police then they would commit suicide and involve me & my daughter for the same and black mail me and force me to register all the land and shop in his name in a illegal manner.
13. That I told my son and daughter in law after my death all the property will be theirs and my daughter will not claim anything but they are determine to register forcefully in a illegal manner.
14. That during this winter season I have to stay out of my house in order to save my live and I am helpless old aged widow and Senior Citizen being tortured mentally and physically by my Son Biswajit Mishra and daughter in law namely Roshani Mishra.
15. That my said son is demanding Rs. 1,00,000/- from me and if I do not pay him then he will kill me and will give poison to me and I am passing my days in great fear & distress.

Under the above facts and circumstances you are requested to please take legal steps against my son and daughter in law who have been torturing me continuously for money and my property in a illegal manner and I want to live peacefully as I am old aged and in ill health & a widow and also request you to stop their illegal act and activities and their rudeness & ill behavior towards me and always beat me and threaten me to kill for their ill motive.
