I, Sonu Choudhary (35) s/o Lt. Bhitka Choudhary resident of Binay Krishnapally, P.S. Matigara West-Darjeeling, beg to inform you that on 13.02.2023 at about 07:00 AM, when my relative namely, Neha Choudhary (22) P/O Sri Manoj Choudhary, of Binay Krishnapally, P.S. Matigara, was at S.F. Road (Near Central Bank of India) at that time one School Bus (Narayana School, Siliguri Branch), bearing Regd. No. WB-73-D-8722, came in a rash & negligent way and badly dashed to her and my said relative Neha Choudhary, received severe injury on her person and immediately shifted to Heritage Hospital, Burdwan Road and admitted there in serious condition.
