Sir,

With due respect and humble submission, in producing herewith one accused namely Ajay Rai (30) S/O Lt Ram bahadur Rai of Puttong ,Panighata,P.S-Mirik,Dist.Darjeeling under arrest along with following articles under proper seizure ;

- i) 27 (Twenty-seven) bottles of KINGFISHER , Strong ,Premium BEER ,each bottle containing 650 ML, each MRP 125/- (Total 17.550 Ltrs)

I ASI Ashit Singh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 16.02.23 at 22.10 hrs I received an information that owner and stuff of Durga Hotel at Siliguri Junction area storage huge quantity of illegal liquor and selling the same .I diarized the fact vide PDN PS GDE NO 895 dtd. 16.02.23. Accordingly I informed to you and as per your direction myself along with force CV/646 Baban Das ,CV/242 Rakesh Mongar held raid in the said Hotel and found that one person stuff of Durga Hotel is selling the liquor , then I detained the above noted person and on being search said hotel recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document with the help of owner of hotel named Roshan Lama for their illegal gain. Accordingly, I seized & label the above noted articles in between 22.35 hrs to 22.55 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Ajay Rai (30) S/O Lt Ram bahadur Rai of Puttong ,Panighata,P.S-Mirik,Dist.Darjeeling and Roshan Lama owner of the Durga hotel and arrange for its investigation.
