Sir,

In producing herewith (05) Five arrested accused persons namely (1) Subhodeep Das-23yrs s/o Lt Sanjay Das of Lower Bhanunagar ward no-43 PS Bhaktinagar Dist Jalpaiguri (2) Alok Sharma-30yrs s/o Balaram Sharma of Gandhinagar ward No-43 PS Bhaktinagar Dist Jalpaiguri (3) Sankar Bhuiya-35yrs s/o Lt Mohan Bhuiya of Kamalanagar, Ward No-42, PS Bhaktinagar Dist Jalpaiguri (4) Deb Das @ Kanai-24yrs s/o Monoranjan Das of Dasarathpally, ward No-44, PO Sevoke road, PS Bhaktinagar Dist Jalpaiguri (5) Sushil Yadav @ Jatla-24yrs s/o Ram Balam Yadav of Dasarathpally, ward no-44, PO Sevoke road, PS Bhaktinagar Dist Jalpaiguri arrested on 18.02.23 u/s- 41 Cr.P.C along with following seized articles viz: -

1. One iron rod measuring about 22 inch (approx) from the possession of accused Sushil Yadav @ Jatla which was kept on his right hand.
2. One iron rod measuring about 20 inch (approx) from the possession of accused Deb Das @ Kanai Das which was kept on his right hand.
3. One iron made Knife approx 8 inch from the possession of accused Sankar Bhuiya which was kept on his right waist.

I, SI Srimanta Chatterjee of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 18.02.23 at 00.05 hrs received a sources information that 10/12 youths have assembled at a jungle in behind ANANDALOKE HOSPITAL Pareshnagar, under Bhaktinagar PS for making preparation to commit dacoity in a house at Bhaktinagar PS area. The fact was diarized in G.D vide Bhaktinagar PS GDE No-1036 dated 18.02.23 Subsequently after sharing the information with my superiors and as per their direction, at 00.15 hrs myself along with PSI Koushik Raha, Const/986 Rajib Sarkar, Const/1431 Dilip Barman, C/915 Chandra Prakash Adhikary CVF/935 Bipplab Roy, CVF/619 Dharmendra Roy, CVF/014 Labannomoy Barman along with kits left for the place to work out the information. Inform night mobile van officer (K-37) ASI Bhushan Ram Singha with a request to remain present there. This refers to Bhaktinagar PS G.D.E No 1037 dated 18.02.23. We reached at a jungle in behind ANANDALOKE HOSPITAL, Pareshnagar under Bhaktinagar PS at 00.25 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 05 (Five) accused persons along with seized articles as mentioned above. However, the other four persons managed to flee away from the spot

taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Bhaktinagar PS area. They also stated that another four others fled away from the spot.


I thereafter, seized the above noted weapons under proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made in between 01.20 hrs to 02.10 hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them.

I accordingly brought the arrested accused persons along with seized article at Bhaktinagar Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit Dacoity in a house at Bhaktinagar PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Subhodeep Das-23yrs s/o Lt Sanjay Das of Lower Bhanunagar ward no-43 PS Bhaktinagar Dist Jalpaiguri (2) Alok Sharma-30yrs s/o Balaram Sharma of Gandhinagar ward No-43, PS Bhaktinagar Dist Jalpaiguri (3) Sankar Bhuiya-35yrs s/o Lt Mohan Bhuiya of Kamalanagar, Ward No-42, PS Bhaktinagar, Dist Jalpaiguri (4) Deb Das @ Kanai-24yrs s/o Monoranjan Das of Dasarathpally, ward No-44, PO Sevoke road, PS Bhaktinagar Dist Jalpaiguri (5) Sushil Yadav @ Jatla-24yrs s/o Ram Balam Yadav of Dasarathpally, ward no-44, PO Sevoke road, PS Bhaktinagar Dist Jalpaiguri and four others and arrange for its investigation.


