Sir,

In producing herewith two accused persons namely 1. Prabin Chhetri (M/40yrs) S/O- Ganesh Chhetri of Iskcon road, Bankimnagar, W.No- 41, P.S- Bhaktinagar, Dist- Jalpaiguri 2. Ranjit Singh (M/31yrs) S/O- Lt Ram Singh of Ashrafnagar, near Masjid, W.No-40, P.S- Bhaktinagar, Dist- Jalpaiguri (not verified) in custody and the following property under seizure along with seizure list:-

- i. 50 (fifty) pieces of vials of DIAZEPAM Injection each vials containing 02 ML. and Marked as exhibit-"A" Total weight 100 ml.
- ii. 50 (fifty) pieces of vials of PHENERGAN Injection each vials containing 02 ML. and Marked as exhibit-"B" Total weight 100 ml.
- iii. 50 (fifty) pieces of vials of LUPIGESIC Injection each vials containing 02 ML. and Marked as exhibit-"C" Total weight 100 ml.
- iv. One TVS NTOQ blue colour Scooty having Reg No- WB 74 BA 2008.

I, SI Koushik Raha S/O- Jitendra Raha of Bhaktinagar PS/ SPC do here by lodged this complaint to the effect that on 19.02.2023 at 21.25 hrs received a secret source information that two persons having possession of huge quantity of Narcotics Substances in his possession without valid documents and coming in a scooty from Sevoke more to Check Post via sevoke road. Accordingly the information was diarized vide BKN PS/SPC GDE No. 1128 Dtd. 19.02.2023 and informed with a written letter to the I/C Bhaktinagar PS/SPC about this information. As per kind order of I/C Bhaktinagar PS/ SPC myself along with, SI Sajal Roy, SI Srimanta Chaterjee, ASI Dipak Karmakar C/1431 Dilip Barman. C/915 Chandra Prakash Adhikary CV/614 Sumit Kr Roy CV/014 Labanyamay Barman all of Bhaktinagar PS/SPC left by govt. vehicle vide BKN PS/SPC M.C.C No-342/23 Dt. 19.02.2023 to verify the veracity of information corresponding BKN PS/SPC GDE.NO. 1129 Dated. 19.02.2023. At the time of departure from Bhaktinagar PS I bring digital weighing machine, envelope, white paper, sealing wax, gum, seal etc. At about 21.50 hrs on arrival at near Payel more in front of City Plaza Building, Sevok road under BKN PS I called two disinterested witnesses from the spot who were present & available there at that time namely (i) Sudeb Mandal (M/46yrs) S/O- Shridham Mandal of Shastri nagar, W.No-41, P.S- Bhaktinagar, Dist- Jalpaiguri M-9832616274, and (ii) Md Nasim (M/43yrs) S/O- Md Saif Hossain of Paresh Nagar, W.No- 44, P.S- Bhaktinagar, Dist- Jalpaiguri M-7430026196 also disclosed the matter regarding our information. I also requested them by issuing a written letter for their Consent to accompany us in the whole process during search and seizure if necessary, and obtain necessary permission of their presence as witnesses in the entire process of Search and Seizure under relevant provision of law as witness. At about 22.15 hrs as per identification by source I managed to stop the said vehicle and found that 02 male persons were riding the above noted vehicle. After disclosing our identity, we detained the above noted persons with strong reason to believe that they are illegally carrying Narcotics Substances in their vehicle dicky in a concealed manner for supplying/ selling the same in Siliguri area for their wrongful gain. On being asked they disclosed their identity as noted above and admitted that they possessed Narcotics Substances. It is also found that one Prabin Chhetri was driven the said vehicle and Ranjit Singh was sitting on backseat. On being asked them they disclosed their identity as noted above. Then I asked them whether they wanted to be search in presence of an special

Executive Magistrate or any Gazetted Officer and they agreed to search by any one. I served them a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and apprehended person to search our Police Party as per provision. But they refused to search by the police party. Then I informed the matter to special Executive Magistrate and requested him to come at Payel more near City Plaza Building under PS Bhaktinagar to remain present and supervise the search and seizure as he being a special Executive Magistrate. After some time Special executive magistrate Shree Passang T. Bhutia ACP(Traffic) East/SPC arrived at the spot. I disclosed the identity of Shree Passang T. Bhutia ACP(Traffic) East /SPC to the apprehended persons and witnesses as a Special executive magistrate. Thereafter under the supervision Shree Passang T. Bhutia ACP(Traffic) East/SPC and in presence of him and independent witnesses I conducted search of the above apprehended persons keeping strict regard and found the articles as per seizure list in the above noted vehicle dikky which was possessing/carrying by the apprehend persons. On being asked they further confessed in presence of Special executive magistrate and other witnesses that they procured the Narcotics Substances clandestinely for the purpose of selling to his designed Customers in order to earn huge amount of money for their wrongful gain. On interrogation they disclosed that they has been dealing in such illegal drug trafficking business and selling the same to the adjacent area of Siliguri, NJP and Bhaktinagar area. On examination of the alleged apprehended persons noted above regarding any documents for carrying/possessing of said Narcotics Substances they failed to produce any documents or license in support of possessing of such drugs. Then as per direction of Shree Passang T. Bhutia ACP(Traffic) East/SPC I seized the articles under proper seizure list and Label under the supervision of Shree Passang T. Bhutia ACP(Traffic) East/SPC in presence of witnesses duly signed by them as well as the accused persons and marked the seized exhibits as noted above.

The seizure and label was made between 22.45 hrs to 23.55 hrs. The whole process of search and seizure was video graphed. Then I arrested the above noted accused persons u/s- 41 Cr.P.C after observing all formalities of arrest and disclosed them cause of arrest issuing necessary Memo of Arrest. The copy of seizure list and Memo of Arrest was supplied to above noted alleged person under proper receipt as the alleged accused persons violated the terms and condition of N.D.P.S Act possessing Narcotics Substances without any lawful documents.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely 1. Prabin Chhetri (M/40yrs) S/O- Ganesh Chhetri of Iskcon road, Bankimnagar, W.No- 41, P.S- Bhaktinagar, Dist- Jalpaiguri 2. Ranjit Singh (M/31yrs) S/O- Lt Ram Singh of Ashrafnagar, near Masjid, W.No-40, P.S- Bhaktinagar, Dist- Jalpaiguri (not verified) and arrange for its investigation.
