I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Indian Electricity Act 2003 amended on 2007 do here by lodge this complain against Surendra Singh (Mob: 9851293189), C/O-Art Reeves Exim(I) Pvt Ltd, Nr-Sneha Garden, Chayan Para, P.S Bhaktinagar, Dist Jalpaiguri. On routine inspection, I, Suman Sengupta, DE & SM, Power House CCC along with Sanjay Prasad, Sr. Office Executive, Power House CCC visited the premises of consumer, Surendra Singh, C/O-Art Reeves Exim(I) Pvt Ltd, Nr-Sneha Garden, Chayan Para, P.S Bhaktinagar, Dist Jalpaiguri bearing Consumer Id: - 400433987 & Energy Meter No: - SF056994 (Make-Secure Meter Ltd., 3*240v, 5-30 Amp. Three Phase) having electric connection from WBSEDCL. The site being at C/O-Art Reeves Exim(I) Pvt Ltd, Nr-Sneha Garden, Chayan Para, P.S Bhaktinagar, Dist Jalpaiguri. We entered the consumer premises on 20.02.2023 at 14:15 Hrs after handing signed copy of the notice to Surendra Singh. On inspection it was found that the meter was shifted from the original place of installation at the above mentioned premises without any valid/proper documents. On further query the consumer failed to produce any valid document to prove authorization of the shifting, thus committing a crime u/s 136 (1) (c) of the Electricity Act 2003, amended on 2007 of India. Accordingly, the inspection report was prepared. The consumer refused to sign or accept the inspection report. We exited the premises on 14.28 Hrs.

Thus you are requested to initiate an investigation against Surendra Singh Under section 136 (1) (c) of the Electricity Act 2003, amended on 2007 Of India
