I Sri Sujit Mahato Son of Late Sita Ram Mahato resident at Dagapur Tea Estate working as Management Executive of Dagapur Tea Estate P.o. Pradhan Nagar Dist Darjeeling 734003. I am lodging First Information Report (FIR) before your Police Station against Sri Amit Munda son of Daman Munda, who is a permanent worker of Dagapur Tea Estate bearing P.F. No 1140. On the reason that on 21st February 2023 at around 8:30 am at morning when I personally in assistance with Souav Sarkar Jr. Asst. Manager of Dagapur Tea Estate went to his house to handed over an official notice to his continuous absenteeism for not attending his duty and job and also his involvement in illegal encroachment and construction both on the Tea Garden Leasehold land.

This is also to inform you that whenever I Sujit Mahato reached to his house and called him to receive the above said notice dated 20th February, 2023 (Photo Copy enclosed), at the time of handing over the notice, suddenly, without any reason Sri Amit Munda became violent and with very aggressive and rowdies manner he had started filthy and most un parliamentary languages towards both of us and also threatened us using the words "**HAM TUMKO MAAR DEGA AUR JAIL CHAALAA JAYEGA**". Within a minute he entered in his room and came out with holding a sharp knife and he started running towards me with an intentions to assault me physically. I became very scared of my life and I run away towards nearest football ground and stumbled and fall down in the football ground and seeing me on the ground, Sri Amit Munda started wielding me with knife. Sir thank God, fortunately the person playing in the ground came and caught him and saved my life from attack of Sri Amit Munda. For your kind information a video proof also kept with me to prove the incidents, if required.

I feel very sacred due to my personal safety and security and hereby requesting to you please take immediate strongest legal action against the culprit above named Sri Amit Munda treating this as First Information Report.

You whole hearted cooperation is hereby highly solicited in this regards.
