He becomes aggressive when I asked about him.
And even today he did same.

Sir, what he did to me is a criminal offence.
He beat me on my face which is an offence
of 'Hurt' under I.P.C. Section 314 and an
affair with that woman is also giving me mental
torture and mental cruelty.

I requesting you to take necessary & strict
action against my husband as soon as possible.
