Sir,

In producing herewith one arrested accused person namely Kanai Hela (43) S/o Lt. Ram Singh Hela Of Lala Raj path Roy road Harijan Busty Ward no 13 PS Siliguri Dist Darjeeling along with seized articles viz, (1) 10(Ten) Bottles of 60 UP Country Spirit styled as Himalayan Gold, 600 ml each, MRP Rs. 155/- Total Rs. (155x10) = 1,550/= (One Thousand Five Hundred Fifty rupees Only) and 2) 01 (One) Nylon Bag which used for carrying the seized articles SL. No. 1.

I, ASI Gazi Rahaman of Panitanki TOP under Siliguri PS, SPC hereby lodge a written complaint against the above noted accused person to the effect that on 05.06.2023 at 08.10 hrs in course of my k-28 morning van duty along with force under Panitanki Top-I area and as per reliable source information as well as direction of OC Panitanki TOP-I, I along with morning van party attend at Bidhan Market Auto Stand, Siliguri this refers Panitanki TOP GDE No. 105 dated 05.06.23 at around 08.25 hrs source point out one person who is proceeding with huge quantity of country spirit liquor containing with a Nylon bag. We intercepted the said accused person with loaded articles on his bag on interrogation he disclosed his identity as above also stated that the bag content huge quantity of liquor ie 10 bottles of 60UP country sprit. On demand he failed to produce any valid documents or license. Accordingly I seized the same under proper seizure list in presence of the following disinterested local witnesses namely (1) Rakesh Kurmi s/o Ramesh Kurmi of Bidhan Road, Ward No.11, SMC, PS-Siliguri Dist. Darjeeling and 2) Manoj Thakur S/o Sita Ram Thakur Das of Natunpara, Ward No.5 SMC, PS-Siliguri Dist. Darjeeling. During. The seizure was made in between 08.35 hrs to 09.15 hrs. I then arrested the said accused person u/s 41 of Cr.P.C. after explaining charge against him. On repeated interrogation accd, Kanai Hela admitted that since long he runs the said business for earn without any valid documents.

Hence, I am submitting this written complaint against the following accused person namely Kanai Hela (43) S/o Lt. Ram Singh Hela Of Lala Raj path Roy road Harijan Busty Ward no 13 PS Siliguri Dist Darjeeling with a request you for starting a specific case under proper section of Law against him and to arrange for its investigation.


