Respected Sir,

With due respect I, **MANJU GUPTA**, S/O Balmiki Gupta, resident Prakash Nagar, Ward No.42 S.M.C, P.O. Sevoke Road, P.S. Bhaktinagar Nagar, Dist - Jalpaiguri, West Bengal- that yesterday at midnight in between 12.30 to 1 a.m. i.e 2/06/2023 my son **AMAN GUPTA** was returning from a birthday party towards his residence. Suddenly near the Biswanath Singh More, **YURAJ KHATI @ GUDU KHATI** S/O Sanjay Khati, resident of Circuit House, P.O. Champasari, P.S. Pradhan Nagar, Dist - Darjeeling, West Bengal and along with **PAWAN RAI**, S/O Viku Rai, resident of Bhanu Nagar, Ward No. 43, P.O. Sevoke Road, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal apprehend my son with sharp weapons and iron rod with intention to kill, that thereafter they are started quarrelling with my son. That my son wanted to escape from them but they forcefully grabbed him and stabbed my son with sharp knife in the middle of the stomach. Later on he has been admitted in Civil Government Hospital Siliguri. That he is presently at the said Hospital and in a critical condition. His life is in danger as these people mercilessly assaulted and stabbed my son. That the aforesaid persons went to the Hospital as well with goons and anti social person and threatened my son on his sick bed as well. They threatened that they shall kill my son if he goes before any police authorities to lodge any sort of complaint against them. They further threatened that once my son is okay and discharged from the hospital they shall again attack him and leave him in the similar life to death condition.

That the aforesaid persons are very dangerous and they have no regard for law, law enforcement authorities or any other authorities, whatsoever. They further stated that no police authorities can do anything to them and they are mafias of this area.

So I therefore request you to look into the matter and do the needful to start a specific case against the aforesaid persons under the provisions of law.

I shall be highly obliged for this act of kindness.
