Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Hill Cart Road (Near Airview More) without any valid documents causing obstruction to public way.

Sir,

I ASI Manotosh Barman of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 25.06.23 around 11.14 hrs, while on duty at Airview More, Hill Cart Road area found one TOTO without any registration number stationed near Airview More, Hill Cart Road in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained said TOTO and on being asked the driver disclosed his name as Raja Sarkar (M-8001317782), 32yrs, S/O- Lalu Sarkar of Bhupendra Nagar, Sakpata, W.No-42, P.S- Bhakti Nagar, Dist- Jalpaiguri. Further on being asked to produce relevant documents in support of his claim of plying TOTO on Major Road he failed to produce any valid documents. Thereafter I seized the TOTO and arrested the person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
