
Subject: F.I.R

Sir,

With due respect in producing herewith one seized vehicle bearing Reg. No. WB 63 B 3499 (Pickup Van) loaded with river bed materials, I PSI Arun Roy of Matigara P.S, SPC lodge this Complaint against the driver/owner of the vehicle bearing Reg No- WB 63 B 3499 to the effect that on 31.07.2023 at 20:30 hrs onwards in course of Mobile van duty I received a specific information that illegal mining is going on at Balason River and transporting by a vehicle bearing Reg. no. WB 63 B 3499. Accordingly myself along with force went to the Balason river near Simultala under Matigar PS, SPC and found that one vehicle bearing Reg. No WB 63 B 3499 loaded with riverbed materials was coming from Balason River near Simultala towards Khaprail Road. I signaled the driver to stop the vehicle but after stopping the vehicle driver fled away leaving behind the loaded vehicle. Then I tried to search the driver/owner of the vehicle but in vein. Then I seized the vehicle bearing Reg. No. WB 63 B 3499 under proper seizure list after observing all formalities. Seizure was made between 21:25 hrs to 21:35 hrs and brought the vehicle at PS compound.

Therefore I pray before you a specific case may kindly be started against the driver /owner of the vehicle bearing Reg. No. WB 63 B 3499 for illegally mining and transporting of riverbed materials, under proper section of law and arrange for its investigation.


