I, Smt. Radhika Chhetri W/O Late Ram Kumar Chhetri resident of Village Putung Khaprail, P.O. Belgachi, Dist. Darjeeling, W.B., Pin - 734423 beg to inform you that on 05th August, 2023 at around 03.26 p.m. when I was returning from Khaprail when I saw my phone I saw my to be son-in-law Sri Niranjan Kumar S/O Harish Ram resident of Pundag Road, P.O. & P.S. Argora, Dist. Ranchi, Pin - 834002, had called me thrice and thereafter when I called him he informed that my daughter Smt. Munna Chhetri who was residing at Vinayak Apartment, Flat No. 202, 2nd Floor (Shivmandir) was not opening the door of the flat and she was not answering to phone calls. That on hearing this I tried to call on her phone but it was ringing but went unanswered. That when I reached to the flat of my daughter and door of the flat was locked thereafter I went to the guard for help but he was busy in some other work as such he could not help me. That thereafter Niranjan Kumar came there and tried to kick and open the door and as it did not work he went upstairs and brought a carpenter who was working in the terrace.

That later the lock of the door from outside was broken by the said carpenter. That inside the flat I went to the right side bedroom and Niranjan Kumar went to the left side bedroom. That when I did not find her within 15-20 second I heard Niranjan Kumar shouting that he found Munna Chhetri hanging in the fan. That when I reached inside the room I found my daughter in the hands of Niranjan Kumar and there was mark in her neck. That there was a yellow printed chunni tied with the fan. That the window curtain rod was lying in the floor. There were many medicines lying in the floor. I was shocked to see my daughter who was not responding to my repeated calls. That the chunni was not cut to bring her down and her head was drenched with water.

That later I called my relatives and subsequently we also found a suicid-location note written in a diary which was lying in the iron table in the room in which has she was found. Later when we analyzed we found that the note was written in Hindi and the handwriting was not of my daughter. Moreover, my daughter have read in a Nepali medium school and she cannot write in Hindi as it is written in the said alleged note. That the sari that she was wearing was also not wrapped properly as it was supposed to be and it looked as if someone has hurriedly wrapped it over her as it was wrapped over her leggings pant and not over a petticoat as a person would never wear a saree at home over a leggings pant.

That later when our relatives checked the CCTV footage of the building it transpired that before 4 p.m. Niranjan Kumar had come to the house 3 times on the same day.

Sir, Niranjan Kumar had come to Shivmandir only 7 days back and stayed with my daughter for 3 days and thereafter he went to stay in some Hotel which he never did earlier. That they had come to Putung on the 30.07.2023 to take me and thereafter I was staying with my daughter. That Niranjan Kumar is a habitual drinker and was most of the time in aberrated condition. That during my stay they kept fighting about various issues and Niranjan Kumar out of jealously kept taunting about my daughter's friendship with Ranadeep Halder.

Sir, after this incident Niranjan Kumar has gone hiding and I tried calling him many times but his phone is either not reachable or switched off. His phone no. is +91 9308582653.

That we also found a black bag inside the room in which few men clothes and one wallet was lying. When we checked the wallet it belonged to one Ranadeep Halder who is a Lieutenant Colonel in Army and presently posted at Sukna. Ranadeep Halder is a friend of my daughter and he frequently used to visit her.

That on 05.08.2023 at around 3.36 p.m. when I reached near the flat of my daughter I saw the vehicle of Ranadeep Halder parked near her building and when I asked his driver he said that they have come to take sweets.

That later when we searched the house properly we found some medical adocuments of my daughter wherein she had undergone an USG of Pregnancy Profile at Mother Care Center, Airport Plaza, Bagdogra on 04.02.2023 and one will with Patient Name Munna Chhetri, Guardian's Name – Ranadeep Halder, Contact No. 9007389188, dated 02.03.2023 of abortion at Mukta Nursing Home, Medical More, Sarada Pally, Shiv Mandir.

That under the circumstances, I have a reasonable doubt that both of the mentioned persons namely, Niranjan Kumar and Ranadeep Halder could be involved in this crime.

Sir, the delay in filing an elaborated F.I.R. is due to her post mortem on 06.08.2023 and funeral which was done yesterday i.e. 07.08.2023.

I, therefore, request you to enter my report in the G.D.E. maintained by you and investigate the matter so that necessary action may be taken against the accused persons mentioned above.
