Sub: F.I.R. against Payel Sen (Dutta) and her husband Vivek Dutta, resident of Sushrata Nagar, New Township, Opp. CRPF Camp, Kawakhali, Dist.- Darjeeling, Pin- 734012, do lodged the FIR against the above named persons in the following grounds.

I Smt. Nandita Dutta, wife of Debabrata Dutta, resident of "Sanyal House" Sushrata Nagar, New Township, Opp. CRPF Camp, Kawakhali, Dist.- Darjeeling, Pin- 734012, District- Darjeeling, is a peaceful and reputed citizen in our Siliguri Town.

That I know the above named persons since long and having a good relation, and due to the said good relation and in good faith with each other, I requested the above named persons to provide some financial help and as per my request the said persons mainly Sri Vivek Dutta through his wife paid sum of Rs. 1,05,000.00/- on three consecutive dates without any interest.

That after receiving the said amount, I along with my husband had paid more or less Rs. 3,52,500/- on different occasion and the above named persons accepted the same by way of UPI. Thereafter suddenly one day said Vivek Dutta came to my house and asked to pay more interests on the said amount and when I denied it, said Vivek Dutta used slang and abusive languages and also started mental torture and stated that without further interests, I cannot receive the principle amount.

That I along with my husband are residing in a rented premises and my only son is residing in Bangalore.

That the said Vivek Dutta threatening me and my husband each and every day to pay more interests, if not then he will abduct our son, not only that he used very offensive words over phone which I cannot spell out the said languages to any relative, friends and well-wishers. He is also threatening that he had some relations with Political Leaders and nobody can do anything against him.

That it is stated that my husband was bound to pay more or less Rs. 3,52,500/- only on different occasions due to his threat and to save my family and reputations. And all the relevant documents in respect of the payment are available in my hands.

That yesterday i.e., on 08.08.2023 at about 11.00 AM the said Vivek Dutta and his wife along with some anti-social aliments came in my rented premises and uses slang languages and threatens me and my husband that if I do not pay more or less Rs.5 lacks within 7 days then I will face very serious consequences.

That in this situation I along with my family members are residing in the above mentioned address in scared and terrified situation and if incident happen against me and my family members then the above named persons are liable.

That in the fact facts and circumstances, I lodged this F.I.R. against the above named persons to take serious and strong steps as per I.P.C. and law of the land.
