Dear Sir,

I Smt Manisha Kedia, Wife of Sri Ashish Kedia, Daughter of Late Late Arun Kumar Sharaf, at present residing at Flat No.D, 4th Floor, Snowhill Residency, Devi Choudharani Road, Opposite Blood Bank, Jyotinagar, Siliguri, Police Station - Bhaktinagar, District - Jalpaiguri, PIN-734001 would like to inform you that I got married to Sri Ashish Kedia (Mobile-8789101959), Son of Sri Rajaram Kedia on 27.04.2013 resident of Sonbarsa Raj, Ward No.05, Main Market, District-Saharsa, Bihar-852129. Right from the beginning of the marriage I did not enjoy the marital happiness due to the greedy nature of my husband and his parents i.e. my in-laws namely Sri Rajaram Kedia and Smt Prabha Kedia who were more interested in earning money through dowry demanded from my parents. At the time of my marriage my father used to be a businessman dealing in a small business earning a basic meager income but inspite of that, used to provide some amount in each month to my husband out of an anticipation that this would please my husband and peace would prevail.

My father was not a big businessman and had his limitations. The demand of my husband and his parents still did not cease and after the death of my father in year December, 2018 my younger brother provided my husband and his parents money on various occasions. After six months of the marriage my husband namely Sri Ashish Kedia started coming to house late at night everyday in an intoxicated state and when intervened by me and questioned by me as to where had you been, my husband used to turn violent and used hands on me and beat me with fists and blows. This instance of physical torture continued for years and I have been tolerating the same. My husband always abused me with filthy language without any reson. My husband has never provided me anything apart from a square meal. Whenever there was a marital discord/fight between us, he did not allow me to keep my mobile with me with a fear that I might inform my parents and relatives.

Out of the said wedlock, two sons were born to us. Since the inception of the marriage, I was never given the minimum respect and

dignity that a wife deserves. I was treated worst than a servant in the family of my husband. My husband used to torture me mentally and physically. Purposefully my husband used to hurt himself so that I get insulted by my in-laws. My husband several times threatened me to commit suicide and thereafter put me in trouble. I could not inform my elder sister or my younger brother as I was not allowed to talk to anyone over phone within the house. I was confined inside the house and would not be allowed to leave the house premises. Furthermore, my husband in one instance brought a PAN card issuance form and gave it to me for putting my signatures. The said form was already filled by my husband. To my utter surprise, my father's name in the said form was written as Sri Rajaram Kedia. Whereas Sri Rajaram Kedia happens to be my father-in-law. I very well knew Pan Card is the only document that only contains the father's name, other the applicant's name. I resisted to sign as the same was not my father's name. I was mercilessly beaten by my father-in-law, my mother-in-law and my husband. Thus I did not sign the application form to save myself. It is pertinent to mention here that one Aditya Kumar (8789390628), younger brother of my husband since our marriage has been staying at Patna. But to make the matters worse as and when he visited us, he too abused me mentally and physically and even used hands upon me several times.

After the birth of two sons, my husband and my in laws have forced me take several kinds of medicines without mentioning the names of the medicine. After the birth of two, I was pregnant for the third time and my husband and my in laws forced me to take medicine which caused my miscarriage. The miscarriage was against my consent upon force and duress. In the year 2020, I with my husband had shifted to Gujarat for his work purpose wherein we stayed for around 2 months. In Gujarat also I got pregnant and after hearing the news of my pregnancy, my husband once again forced me to take some medicine against my will which once again caused miscarriage.

Since I could not inform anyone about my situation, finding no other alternative I had to run away from my matrimonial house leaving by two children and my stridhan proterty in my matrimonial house. On 25.11.2022, I left my matrimonial house and came to Siliguri and thereafter have been residing with my elder sister. Sri Ashish Kedia is calling me over telephone since few days and threatening me to abduct me from Siliguri using his muscle men and

agents. Furthermore Ashish Kedia has also filed a false case for divorce against me at the Court of Patna

I therefore request you to investigate the matter and book the culprits namely Sri Ashish Kedia (my husband), Sri Rajaram Kedia (my father-in-law), Smt Prabha Kedia (my mother-in-law) and Aditya Kumar (my brother-in-law) in accordance with the appropriate provisions of law.
