holiday I asked him to help me in assembling the music system and also asked him to be in the vehicle so that no one does any mischief with the music system and the speaker as it was a very important day.

③ That after the procession begins from Ashraf Nagar at around 9:30 to 10:00 AM my son was with the vehicle in which the music system and the speaker was installed to look after the machine function and for the over all safety. But as soon as the procession was about to reach Paitanki more just before that few children onboard the said vehicle on which my son was looking after the music system and started touching the wires and other music system machine and when my son tried to stop him from not doing so

Those children started abusing my son in filthy language and started assaulting with fist and blows on the stomach of my son in defence when my son tried to stop the said children a person namely Saddam Hussain came aggressively and started assaulting my son with fist and blows and kicks and with iron nuckles because of which my son received grievous hurt and received injuries on his face and chin and a lot of blood came out. In the mean time when I went to save my son he snatched my sons gold chain weighing 11.5 gm. and took Rs 510 cash from his pocket and run away.

④ That after that incident I took my son to Bilgaon Hospital where he was treated and given medicines for the same.

⑤ That the said Saddam Hussain
s/o Abdul driver of ashraf Hagen
is a habitual offender and has
been charged by police many a
time, he is also into buying
and selling and consuming

drugs/brown sugar because of this
he has been arrested many times.
He is very dangerous person Sir,
and my son Joravel also
to his school and tuition he can
do anything wrong to my son
any time as he is already
threatening us with dire consequences
if we file a complaint against
him.

Therefore request you to
kindly take necessary legal
action against the above said
Saddam Hussain for the ends
of Justice.
