This is to inform you that on date at around 12pm near Panitanki Clock Tower, my 12 year old son Md. ALTAF was peacefully walking with the procession on occasion of Eid_Milad_un_Nabi, Thursday 28th September 2023.

Due to extreme hot and humid weather and out of tiredness he sat on a procession vehicle, within minutes some unknown strangers came towards my son and started assaulting him with fists and blows and slaps, abusing him with filthy languages, for resting on the procession vehicle. Later I came to know that the miscreant is Mrs. Subhra Saha (Khatoon) a self acclaimed reporter she was doing video of the procession, his husband Md. Manoj and her in law Md. Mustak, son of Late Md. Jabbar of Ashrafnagar and Some Md. Monty.

His friends, commuters and his uncle accompanied my son to home, and I took him to OPD, Siliguri SD Hospital for treatment of his injuries. According to on duty officer he suffered abrasion over face, nail scratches and head injuries.

Sir, They threw an open challenge that she is a big shot reporter and her in-laws hold strong politically influence. Nobody can dare to raise objection against them. We are in complete mental shock and fear. We anyhow managed to save my son from those hooligans and outrageous antisocial. Unfortunately the "DADAGIRI" that took place was stone throwing distance from nearest Panitanki Police out-post. I request you to kindly investigate the matter, how they can assault a minor for a petty reason in broad daylight? behind excuse of Press & Politics. I also wish to know the RNI No. of Subhra Saha, which her media house holds to run the Press. As it is illegal to run any media cell without the Registration No. of The Office of the Registrar of Newspaper of India (RNI) in an attached office of the Ministry of Information & Broadcasting and a statutory office under Section 19(A) of the Press & Registration of Books Act, 1867. Sir, justice delayed is justice denied.

Sir, My minor son is a victim of trauma, vandalism, and above all unprecedented "dadagiri" of Subhra Saha (khatoon) and others.

Your immediate action his highly solicited, SOS and oblige.
