Sir, in the year 2021, I got acquainted with one Smt. Uttara Roy, wife of Sri Lalit Choudhury and on being acquainted with her, she stated that her marriage has already been dissolved by a decree of divorce & she has been struggling with financial crisis with her minor children & since then, on some false plea, she used to take money from me and considering her said situation and also believing her said version UP 420/447/ to be true, I have paid money to her on several occasion and she has continuously induced me by her systematic false words.

Sir, thereafter, on being induced by her, I have also agreed to marry her and accordingly, we got married on 19.01.2022 in a Kalibasi at Champasahi but immediately after our marriage, I noticed a bound some radical changes in her attitude & behaviour, she always created pressure upon me to pay money to her as per her demand and as and when, I have failed to pay the same, she used to assault me & threatened me with dire consequences.

Thankably, I came to know that her previous marriage has not been dissolved and still her marital relation is existing and she has intentionally made such false statement before me for her illegal gain and by this way she has cheated many persons.

Knowing the said fact when I made protest against her and asked her as to why she did the wrong with me, she started to threaten me that still and unless I will pay a sum of Rs. 25,00,000/- to her, she will not leave me otherwise, she will implicate several false cases against me and in order to save myself, I have paid her such amount with a hope that I may able to come out from the said scam but no fruitful result occurred. In spite of receiving such amount from me, she has been continuously threatening me & lodged several complaints against me with some false allegations.

Sir, today i.e. on 29.09.23 at about 3.50 pm to 4.00 pm, said Uttara Roy suddenly came to my said shop and started to make hulla in presence of my employee Sri Mohan Prasad and other adjacent shop owners and demanded money from me and when I refused the same, she forcefully entered into my shop room and started to assault me physically and also damaged the products of my shop, cutv cable, etc. and when I made protest against her, she herself cut her body and threatened me that she will again lodge false complaint against me by showing such self cutting injury and at the time of leaving she forcefully took cash from the cash box of my shop & assaulted me with fist & blows.

I, therefore, request you to kindly investigate into the matter & please take appropriate legal action against her so that I can lead my life peacefully otherwise, she will not hesitate to finish my life permanently.
