contest the suit, he started beating me. He attacked me with a knife from his store and cut my finger which resulted in blood flow. He also hit me on the leg with wooden block causing bruises and severe pain. He snatched my gold chain of 5 gm. causing marks in my neck. Medical documents are attached. He also slapped me twice with force.

I am apprehending danger to my life as he may reverse to any extent to get me divorced as he already had married 3 times.

I therefore request you to treat this complaint as FIR and arrest him and take legal action against Yograj Baraja.
