In producing herewith Five (05) arrested accused persons namely (1) Tapash Mahanta (24 yrs) S/O- Lt. Ram Mahanta of Durga Das Colony, Ward No-20, PS- Siliguri, Dist- Darjeeling (2) Rabi Gupta @ T:ki (M/20), S/O-Sat Narayan Prasad Gupta of Shimul Tala, , Balasan, PS-Matigara. Dist. Darjeeling, and (3) Surajit Chakraborty (M/24), S/O- Dilip Chakraborty of Durga Mandir road. South Shanti Nagar, PS- Bhaktinagar, Dist- Jalpaiguri (4) Koushik Kar @ Kousihk (M/21 yrs) S/O- Lt. Kartik Kar of 1 No Dabgram, Ward No-23, PS- Siliguri, Dist-Darjeeling (5) Bharat Singh (M/18 yrs) S/O- Kapil Singh of Jyoti Nagar Colony, Ward No-04, PS- Siliguri, Dist-Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

1] One metal made knife measuring about 12 inch (approx) including wooden butt from the possession of Tapash Mahanta which was kept on his right hand.

2] One iron claw bar measuring 17 inch (approx), from the possession of Rabi Gupta @ Tiki which was kept on his hand.

3] One metal made Rambo Knife measuring 10 inch (approx) including wooden handle from the possession of Surajit £hakraborty which was kept concealed on his back side.

4] One iron made Khukri measuring 18 inch (approx) including wooden butt being the metal portion kept inside a wooden cover from the possession of Koushik Kar @ Kousihk which was carrying on his right hand.

5] One iron hammer measuring 18 inch (approx), from the possession of Bharat Singh which was kept on his hand.

I, SI Biswajit Sarkar S/O Lt. Joydeb Sarkar of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others viz. Rabi, Surajit, Nasu, Md. Sagar, Kathal and others to the effect that today on 17.10.2023 at 00.45 hrs received a sources information that 14/15 youths have assembled at Fuleswari near Fish Market with a view to commit dacoity in a house at South Bharat Nagar area. The fact was diarized in GD vide Siliguri PS GDE No-1014, dated 17.10.2023. Subsequently after sharing the information with I/C Siliguri PS and as per his direction, myself along with ASI- Subir Sen, ASI Debasish Das, CV/622 Ramanath Barman and CV/283 Prasenjit Dey, left for the place to work out the information. On way I contact ASI Sanjay Basunia who was performing k-21 Van to accompany us to work-out the information. We reached at Fuleswari near Fish Market club at 01.05 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from Fuleswari near fish Market, seeing police personnel they tried to flee . away from the spot but on hot chase we managed to apprehend above noted Five (05) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at South Bharat Nagar area with the leadership of Rabi Gupta @ Tiki.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.45 hrs to 02.20 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them. Due to late night independent witness not available.

Accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at South Bharat Nagar area. It is also revealed from them that (1) Rabi, (2) Surajit, (3) Nasu (4) Md. Sagar (5) Kathal, and some others have been assembled there with them and planned for committing the dacoity..

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Tapash Mahanta (24 yrs) S/O- Lt. Ram Mohanta of Durga Das Colony, Ward No-20, PS- Siliguri, Dist- Darjeeling (2) Rabi Gupta @ Tiki (M/20), S/O-Sat Narayan Prasad Gupta of Shimul Tala, , Balasan, PS- Matigara, Dist. Darjeeling, and (3) Surajit Chakraborty (M/24), S/O- Dilip Chakraborty of Durga Mandir road, South Shanti Nagar, PS-Bhaktinagar, Dist- Jalpaiguri (4) Koushik Kar @ Kousihk (21 yrs) S/O- Lt. Kartik Kar of 1 No Dabgram, Ward No-23, PS- Siliguri, Dist- Darjeeling (5) Bharat Singh (18 yrs) S/O- Kapil Singh of Jyoti Nagar Colony, Ward No-04, PS- Siliguri, Dist- Darjeeling (6) Rabi, (7) Surajit, (8) Nasu, (9) Md. Sagar (10) Katahl, and others and arrange for its investigation.
