Sir,

With due respect, I am producing herewith one arrested accused person namely Kanai Hela (44) yrs s/o Lt. Ram Singh Hela of Lala Lajpath Roy Road, Harijan Busty, Ward No.- 14, PS- Siliguri, Dist.- Darjeeling under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 10 (Ten) Bottles of Himalayan Gold Country Spirit containing 600 ml in each bottle.
2. One Nylon Bag.

I, ASI Ratan Ghosh presently attached with Panitanki TOP, under Siliguri Police Station, Siliguri Police Commissionerate under your kind control beg to state that today i.e. on 17.10.2023 at 08:15 hrs I received a secret source information that one person namely Kanai Hela (44) yrs s/o Lt. Ram Singh Hela of Lala Lajpath Roy Road, Harijan Busty, Ward No.- 14, PS- Siliguri, Dist.- Darjeeling is going from Bidhan market towards Panitanki More carrying huge quantity of ID liquor in one nylon Bag. Accordingly, I diarized the fact in the General diary vide Panitanki TOP GDE No.-349 dated 17.10.2023 and informed the fact to you. As per your kind direction and instruction myself along with C/899 Somnath Roy, CV/377 Dinesh Roy all are of Panitanki TOP, under Siliguri PS, SPC left for Bidhan Road, PS- Siliguri, Dist.- Darjeeling, to work out the information in hand. At about 08:35 hrs we arrived at Bidhan Road, near auto stand, PS- Siliguri, Dist.- Darjeeling, and being identified by the source I apprehended the accused person carrying one nylon bag. Accordingly, on being asked he disclosed his name and address as noted above and on further interrogation he state that he carrying illegal Distilled Liquor to sell to his design customer under different area of Siliguri. On being search of Nylon Bag Carrying by him the above noted I/D liquor is recovered from the bag carrying by him. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 08:55 hrs to 09:25 hrs on 17.10.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Kanai Hela (44) yrs s/o Lt. Ram Singh Hela of Lala Lajpath Roy Road, Harijan Busty, Ward No.- 14, PS- Siliguri, Dist.- Darjeeling and arrange for its investigation.
