I Smt. Gita Bhattacharjee, resident of Loknath
nagar, Bagdogra, dist. Darjeeling, beg to report
you that today 22nd Jan, 2024 at the afternoon,
a rented named Mr. D.V. Sharma, who is
residing in the flat of Mr. Kamalesh Chakraborty.

So, today at 2:00 p.m., one courier guy came & for
security reasons, I told that there will be ^{no} delivery
of parcels inside the building, instead the
parcels should be taken from the main-gate or
to be come down for any pickup. But, Mr. D.V. Sharma
denied to this statement & started arguing
& mis-behaving me. And during this argument
this person suddenly heated up & then he
pulls his mobile phone & started showing me
a video (which was already been removed
from the internet on 21st Feb, 2022 by Siliguri
Police Commissioner - Mr. Gaurav Sharma).

Also, this person (renter) tried to threaten &
mis-behaved with me including my character
in public. Including this, as this conversation

goes on, my son confronts him to stop saying non-sense & then immediately he also threatened my son as he (this person) & Kamlesh Chakraborty will ruin his career, through mobile.

Please take necessary actions against Mr. Kamlesh Chakraborty (Ph. 94755 86152) & Mr. D.V. Sharma.

The present circumstances are causing considerable mental distress, hindering my ability to lead a peaceful life.
