of physical assault happened to my father at the above mentioned
property.

The incident occurred at approx 9:00 pm on 1st of Feb 2024
As narrated by my father while taking him to hospital he said "
He was talking to a customer in the shop and the customer left
the shop he (accused) suddenly entered with a wooden log and hit
him several times on his head leading to several injuries, he
also used a chair for attacking and hit him with the chair too

The person who attacked my father was working as a
staff at my shop. His name is Anishan Rai S/O Roshan Rai
Currently resident of, "Address: Tenant at the house of Viney
Kumar Jha, Near CCN cable Office, Pateswari School, Tyotinagar

After hitting my father, when he got unconscious, one tenant
staying in my premise ran to my shop hearing the noise. Her
name is Nisha Lama, when she reached the shop she saw
him carrying that chair which he had used to hit my father &
was about to hit again, she begged him to leave from there &
he soon fled away.

I reached the spot after 5 mins and saw the whole floor drained
with blood, my father lying on the floor unconscious. Soon I took him
to mandolee Hospital.

I request you to please take strict action against him (accused)
