I, Ranadip Mazumder, Son of Kalipada Mazumder A.E & SM Power House CCC, empowered by The Indian Electricity Act 2003 amended on 2007 would like to lodge a complaint against Nagendra Ray bearing Con ID 412214549, (Meter No SE0563243, Make Schneider Electric India P L, Single Phase, 240V, 5-30Amp) resident of S/O-Jasi Ray, Nr.Maink Saha Home, Lower Bhanunagar, Sevoke Road, Siliguri. The Consumer is a defaulter and had Outstanding Amount approx. Rs 10311. Agency, M/S Ghosh Electro Mach was entrusted to disconnect the consumer for Power House CCC, WBSEDCL. Birju Dey, authorized personnel from M/S Ghosh Electro Mach went for disconnection on 15.02.2024 at around 15:35 hrs. Service Connection was disconnected by cutting the outgoing cable of Meter SI No SE0563243. When he was boarding his scooty for returning towards the office, he was pushed and shoved, and was detained by the family members of Mr Nagendra Ray. Also, those family members of Mr Nagendra Ray attempted to snatch his phone. He immediately reported to the undersigned about this incident.

Hence, I, Ranadip Mazumer (A.E & SM Power House CCC), along with my office staffs and others reached the spot and rescued the personnel of M/S Ghosh Electro Mach at around 16:25 hrs.

As such you are requested to look into the matter and treated this as a FIR.
