politely to return me the Money then he became
furious and started Assaulting me with his helmet
and also pulled my hair and punched me and also
tried to strangle me by a rope and when seeing
all this my Above Mentioned Son tried to save me
then he also assaulted him brutally by a sharp
cutting weapon over his head for which he became
unconscious for a while and also Suffered 3 Stitches
over his head It is important to mention here that
due to his Attack my Son could have died as he was
having full intention and Knowledge of killing us
and attacked us with a full Motive of killing us.
