Sir

In producing herewith following three accused namely 1) Rajiv Chhetri (27yrs) S/O Sankar Chhetri of Setong Kurseong PS Sevoke Dist Darjeeling (not verified), ii) Biswanath Basfore (22yrs) S/O Lt Ragunath Basfore of Salugara near Swastik apartment PS Bhaktinagar Dist Jalpaiguri (not verified), iii) Biren Rai (31yrs) S/O Lt Budhi Prakash Rai of Samsing west PS Metli Dist Jalpaiguri(not verified) with following seized articles viz:

- 1) One iron made sharp cutting knife and one iron rod (sabol) measuring 18 inches recovered from the conscious possession of Rajiv Chhetri
- 2) One iron made 'Knife' and rope recovered from the Conscious possession of Biswanath Basfore.
- 3) One iron made weapon called as 'Bhojali' 14 inches recovered from the conscious possession of Biren Rai

I, ASI Chandra Prakash Adhikari S/O Lt Khara nanda Adhikari of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted) Rajiv Chhetri (27yrs) S/O Sankar Chhetri of Setong Kurseong PS Sevoke Dist Darjeeling (not verified), ii) Biswanath Basfore (22yrs) S/O Lt Ragunath Basfore of Salugara near Swastik apartment PS Bhaktinagar Dist Jalpaiguri (not verified), iii) Biren Rai (31yrs) S/O Lt Budhi Prakash Rai of Samsing west PS Metli Dist Jalpaiguri(not verified) and 9/10 others to the effect that on 21.03.2024 at 00:15 hrs received a specific source information that 12/13 miscreants have assembled at Bethgera Daragaon under Bhakti Nagar PS, Dist.- Jalpaiguri with deadly weapons and making preparation for committing dacoity at Salugara area under Bhaktinagar PS Accordingly, I informed the matter to the I/C, Bhakti Nagar PS and diarised the fact in General diary vide Bhakti Nagar PS GDE No 994/24 dated 21.03.2024 and as per order I along with SI Rantu Haldar, ASI Dipak Karmakar, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Fauji Math near Pyare Singh Dhaba under Bhakti Nagar PS, Dist.- Jalpaiguri to work out the information in hand.

At about 00.35 hrs we arrived at Bethgera Daragaon under Bhakti Nagar PS, Dist.- Jalpaiguri as indicated by the source we noticed that 12/13 persons assembled at Bethgera Daragaon under Bhakti Nagar PS, Dist.- Jalpaiguri and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after a hot chase managed to apprehended above noted 03 (three) of them with deadly weapons in their possession but 9/10 persons managed to fled away from the spot taking the advantage of darkness and open place.

On interrogation the apprehended accused persons disclosed that they were present at the place noted above and also stated that the following persons namely Alamgir, Prithivi sonar, Bao and others were present there and making preparation for committing dacoity at Bethgera Daragaon under Bhakti Nagar PS, Dist.- Jalpaiguri. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 21/03/2024 in between 00.55hrs and 01.45 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 03 (three) arrested accused persons namely i) Rajiv Chhetri (27yrs) S/O Sankar Chhetri of Setong Kurseong PS Sevoke Dist Darjeeling (not verified), ii) Biswanath Basfore (22yrs) S/O Lt Ragnath Basfore of Salugara near Swastik apartment PS Bhaktinagar Dist Jalpaiguri (not verified), iii) Biren Rai (31yrs) S/O Lt Budhi Prakash Rai of Samsing west PS Metli Dist Jalpaiguri(not verified), iv) Alamgir, v) Prithivi sonar,vi) Bao and others kindly arrange for its investigation
