Sir,

In producing herewith one (02) arrested accused person namely 1) Junaid Mia (21) S/O Abul Kasim of Paqua, PS. Paqua Dist. Cox Bazar, Bangladesh 2) Kabir Husain (22) Akash Molla of Ramchandrapur, PS Humna Dist. Cumilla, Bangladesh

I, SI Tanmoy Kundu of New Jalapiguri PS , Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted two accused person to the effect that on 29.06.24 at about 20.05 hrs, I received a specific source input that two Bangladeshi nationals were loitering in suspicious manner at Fulbari Bazar, near Battala. The matter was diarized in New Jalpaiguri PS GDE No. 1647/24 Dt. 29.06.24 Subsequently, I informed the matter to you and with your prior permission and being directed, myself along with C/1662 Sajan Tamang , C/152 Abdul Karim Mia VP13 Jamirul Islam left for Fulbari under New Jalapiguri PS by Govt. vehicle to verify the veracity of the information. This refers to NJP PS. Gde No 1648 Dt 29.06,24.


After reaching Fulbari Bazar near Battala under New Jalpaiguri PS at around 20.05 hrs, After a while thereafter being pointed by my source, detained 02(Two) person mentioned above who was coming out from Fulbari side on foot. We disclosed our identity. On asking both, the suspect person disclosed their identity as 1) Junaid Mia (21) S/O Abul Kasim of Paqua, PS. Paqua Dist. Cox Bazar, Bangladesh 2) Kabir Husain (22) Akash Molla of Ramchandrapur, PS Humna Dist. Cumilla, Bangladesh and they admitted that they are citizens of Bangladesh and entered into India territory by crossing international borders in an illegal way through Fulbari Border for illegal means or searching for job. Thus they violated the provision Indian Foreigners Act.


Hence, I arrested the above noted two accused persons namely 1) Junaid Mia (21) S/O Abul Kasim of Paqua, PS. Paqua Dist. Cox Bazar, Bangladesh 2) Kabir Husain (22) Akash Molla of Ramchandrapur, PS Humna Dist. Cumilla, Bangladesh u/s 41 CrPC. They were searched but found nothing except wearing appeals & after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started namely 1) Junaid Mia (21) S/O Abul Kasim of Paqua, PS. Paqua Dist. Cox Bazar, Bangladesh 2) Kabir Husain (22) Akash Molla of Ramchandrapur, PS Humna Dist. Cumilla, Bangladesh and arrange for its investigation.
