In producing herewith (i) Suman Kumar Choudhury (42), S/O- Sri Tej Narayan Choudhury of Banmankhi near Radha Krishna Mandir PS Banmankhi Dist. Purnia, Bihar (ii) Ritesh Kumar Changotiya (44) S/o Raj Kumar Changotiya of Banmankhi near Radha Krishna Mandir PS Banmankhi Dist. Purnia, Bihar (iii) Rajiv Ranjan Nirala (45) S/O Badyanath Prasad of Neheru Chack Gupta patti Banmankhi PS Banmankhi Dist. Purnia, Bihar (iv) Suparna Saha (27) D/o Nipendra Saha of Suryasen Colony PS NJP Dist. Jalpaiguri (v) Puja Roy (19) D/o Paresh Roy of Fulbari Hat PS NJP Dist. Jalpaiguri (vi) A\mita Barman (21) D/o Abinash Barman of Noukaghat Porajhar PS NJP Dist. Jalpaiguri under arrest and the following articles are seized (a) One packet of Moods condoms ultra thin containing two condom, (b) One "Deluxe" Nirodh containing five numbers of condoms, (c) One maroon and another red colour ladies inner garments (panty) under Proper seizure List in presence of the witnesses. I beg to report that today on 29.06.24 at about 23.57 hrs, I received a reliable source information that a brothel was being run in the Hotel of The Autograph inn situated at Eastern bypass, Thakur nagar under NJP PS with the help of three or four young lady and presently they engaged with some customers in the said Hotel. This refers to New Jalpaiguri PS GDE No 1659 Dated 29.06.24.The matter was informed to ACP, East-II, SPC (The presence of senior officer could not be availed without affording the accused persons to escape or enhance the concealment of evidence) and as per kind order of superiors myself along with S.I. Ganesh Roy, S.I Tanmay Kundu, ASI Sushanta Mandal, LC-1328 Sangita Maley, LC- 1235 Anita Roy, with night van Officer SI Madan Rishi and C/1062 Goutam Shil , CV-308 Monaj Roy to work out the information vide NJP PS GDE No- 1659 Dated 29.06.24. I along with my team arrived at the alleged place on 30.06.24 at 01-15 hrs and being indentified my source reached the alleged Hotel, one seeing police the Owner and Manager with all staffs of Hotel fled away from that place, then we entered into it as the door was unlatched from inside. We approached the inside living room of the Hotel and found that three man and three lady on the bed inside the said hotel room in an intimate compromising position without any garments on their persons. Seeing the police party they became separated. Both three couples when asked about their identity disclosed their names and addresses as mentioned above. One packet of Condom Containing with Two Condoms was lying on the bed where the above alleged persons were lying and Two Ladies inner garments (Panties) lying on bedsheet in the room. All the accused persons initially made incoherent statement but later confessed the truth. The accused noted in SI. no- iv confessed that she was running a prostitution with knowledge the Owner and Manager of the said Hotel The Autograph Inn and attracting the Youths in Lieu of High Amount of Money. The accused noted in SI. no- i & iii in the said Hotel for having sexual intercourse by paying money and today they came there for sexual intercourse in lieu of high amount of money. The accused noted in SI. no-iv is living solely on the earnings of prostitution. The accused person noted in SI. no- iv confessed her guilt stating that she is assisting by the accused no-v & vi to carry on the business and accused noted in SI. no- ii assists her in running such illegal, and dirty profession.

Under the above circumstances, I have strong reason to believe that all of the accused persons committed the offence under ITPA Act 1956. Arrested all the accused persons u/s- 41 Cr.P.C. and seized the available alamats at the PO in presence of available witnesses namely (i) Amit Roy (26) S/o Bablu Roy of Madani Bazar PS NJP Dist. Jalpaiguri & (ii) Gouranga Sarkar (26) S/o Balaram Sarkar of Thakurnagar near Jano Sangha Club Ground PS NJP Dist. Jalpaiguri.

During local enquiry, it could be revealed that accused no-iv with the help of accused SI No. ii, v & vi had been running the prostitution business from that Autograph Inn Hotel since last few months and several male persons including the accuse no-i & iii are seen to be visiting the Hotel for sexual intercourse and that all the accd. persons were using the hotel located in the vicinity of the public place for earning their living by offering her body for promiscuous sexual intercourse for their illegal gain and other customer.

Jup of purce Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against (i) Suman Kumar Choudhury (42), S/O- Sri Tej Narayan Choudhury of Banmankhi near Radha Krishna Mandir PS Banmankhi Dist. Purnia, Bihar (ii) Ritesh Kumar Changotiya (44) S/O Raj Kumar Changotiya of Banmankhi near Radha Krishna Mandir PS Banmankhi Dist. Purnia, Bihar (iii) Rajiv Ranjan Nirala (45) S/O Badyanath Prasad of Neheru Chack Gupta patti Banmankhi PS Banmankhi Dist. Purnia, Bihar (iv) Suparna Saha (27) D/O Nipendra Saha of Suryasen Colony PS NJP Dist. Jalpaiguri (vi) Almita Dist. Jalpaiguri (vi) Puja Roy (19) D/O Paresh Roy of Fulbari Hat PS NJP Dist.
