Subject: First Information Report (F.I.R).


Kindly refer to the above.

Today i.e., 20/08/2024, at around 1P.M. my sister-in-law Smt. Binita Sewa Mangraty, w/o – Shri Durga Charan Mangraty, resident of 38, Pragati Path, Jyotinagar, Ward- No.-41, P.O.- Sevoke Road, P.S. Bhaktinagar, Dist-Jalpaiguri, Siliguri-734001 was hit by a car in front of the Gate of Don Bosco School, Siliguri. My sister-in-law was about to board the toto with my nephew Master Aarav Mangraty when the vehicle bearing registration no-WB02/AP3850 Hyundai Model car of silver colour, smashed into my sister-in-law and my nephew alongwith three other ladies(parents) and one other child of the school. My sister-in-law has been seriously and grievously injured with injuries to her head and body and currently admitted in ICU at Dr. Nayak's Nursing Home, Siliguri. As per the details given by the other parents and witnesses there were two men in the said vehicle were driving at high speed and were heavily intoxicated.

In context to the above, I request you to kindly register my F.I.R. and take strong necessary action against the above mentioned two men who were present inside the above mentioned vehicle. I want to file this F.I.R. to take legal course of action against the said individuals for attempt to murder of my sister-in-law and almost causing loss of lives of both my sister-in-law and nephew due to their abject negligence and rash driving and fleeing the scene of accident.
