In producing herewith arrested accused person namely Pintu Mandal (33 yrs) S/O Late Anukul Mandal of Rana Busty, Shraban Nagar, Ward No. 18, PS- Siliguri, Dist- Darjeeling along with seized articles vize i) 35 sealed bottles of Master Blender's Signature Premium Smooth & Creamy Whiskey containing 180 ml each amounting of Rs.290/-, marked as Exibits-A, (ii) one sealed bottle of Master Blender's Signature Premium Smooth & Creamy Whiskey containing 180 ml which was taken from Exibits A as sample, marked as Exhibits-A1, (iii) 30 sealed bottles of Sterling Reserve BJ Finest Blended whiskey containing 180 ml each marked as exhibits-B, iv) one sealed bottle of Sterling Reserve BJ Finest Blended whiskey containing 180 ml which was taken from Exhibits from B as sample, marked as Exhibits as B1, (v) 28 sealed bottles of Iconiq White Special International Grain Whiskey containing 180 ml each, amounting Rs. 190/- each, marked as Exhibits-C, (vi) one sealed bottle of Iconiq White Special International Grain Whiskey containing 180 ml which was taken out from Exhibits C as sample, marked as Exhibits C1, (vii) 25 sealed bottles of Royel Stag Superior whiskey conrtaining 180 ml each amounting of Rs. 220/each marked as Exhibits as D, (viii) one sealed bottle of Royel Stag Superior whiskey conrtaining 180 ml which was taken from Exhibits D as sample, marked as Exhibit D1 as per seizure list.

I, SI Uday Chakraborty of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Pintu Mandal (33 yrs) S/O Late Anukul Mandal of Rana Busty, Shraban Nagar, Ward No. 18, PS- Siliguri, Dist- Darjeeling to the effect that on 26.01.25 at 21.15 hrs acting on secret source information that the above noted person was busy to sale huge quantity of Foreign liquor illegally at his house situated at Rana Busty,

Shraban Nagar, Ward No. 18 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE dated 26.01.25 and informed the fact to I/C Siliguri PS. As per no. 1604 direction of I/C Siliguri PS, I along with ASI Debasish Das, ASI Subir Sen, C/160 Soumen Sarkar both of Siliguri PS left for Rana Busty, Shraban Nagar, Ward No. 18 under Siliguri PS to verify the veracity of the information vide Siliguri PS 26.01.25. On reaching at 21.35 hrs there and as G.D.E No.1605 dated identified by source cordoned the above noted area where he was selling Foreign alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, he disclosed his identity as noted above. On being asked he stated that he used to sale the Foreign liquor to locality without any valid documents. On being asked he could not produce any valid documents in respect of the said liquor. On searching i i) 35 sealed bottles of Master Blender's Signature Premium Smooth & Creamy Whiskey containing 180 ml each amounting of Rs.290/-, marked as Exibits-A, (ii) one sealed bottle of Master Blender's Signature Premium Smooth & Creamy Whiskey containing 180 ml which was taken from Exibits A as sample, marked as Exhibits-A1, (iii) 30 sealed bottles of Sterling Reserve BJ Finest Blended whiskey containing 180 ml each marked as exhibits-B, iv) one sealed bottle of Sterling Reserve BJ Finest Blended whiskey containing 180 ml which was taken from Exhibits from B as sample, marked as Exhibits as B1, (v) 28 sealed bottles of Iconiq White Special International Grain Whiskey containing 180 ml each, amounting Rs. 190/- each, marked as Exhibits-C, (vi) one sealed bottle of Iconiq White Special International Grain Whiskey containing 180 ml which was taken out from Exhibits C as sample, marked as Exhibits C1, (vii) 25 sealed bottles of Royel Stag Superior whiskey conrtaining 180 ml each amounting of Rs. 220/each marked as Exhibits as D, (viii) one sealed bottle of Royel Stag Superior whiskey conrtaining 180 ml which was taken from Exhibits D as sample, marked as Exhibit D1 and accordingly I seized the same as per seizure list as per seizure list in which was kept concealed in his house under Siliguri PS as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. He also stated that he is doing this liquor business since long for his wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 21.55 hrs and 22.45 hrs. As such I arrested him U/S-35(1) BNSS after observing all sorts' of rules. Whole searched and seizure processe was made
